

Equipment hire

Terms and Conditions of supply.

- 1) **General**
These terms and conditions apply to all Hire Contracts unless otherwise expressly agreed in writing by H₂O pro Pty Ltd
- 2) H₂O Pro Pty Ltd reserves its rights to accept all or any part of any order by the hirer or to refuse such order.
- 3) H₂O Pro Pty Ltd makes no guarantee that items of equipment will be available for hire at all times. However every effort will be made to fill an order once it is confirmed.
- 4) **Period of Hire**
The period of hire shall commence on the date of delivery or collection and shall cease on the date the hire goods are received by H₂O Pro Pty Ltd. Hire charges are based on a Daily (24 hour) Rate.
- 5) **Charges**
A charge will be apply for all hire goods. Charges will be stipulated on this contract, under the section titled "Schedule of Charges"
- 6) Charges are payable in full in advance, or if credit has been arranged they will be invoiced to the hirer at the conclusion of the hire for hire periods of 30 days or less. Where a hire period exceeds 30 days, hire charges will be invoiced monthly.
- 7) **Credit Terms**
Where Credit has been arranged, Hire charges are due and payable as at the date of invoice. H₂O Pro Pty Ltd will provide a 30 day interest free period in which to arrange payments. Any payment exceeding this period will be subject to a \$33.00 late payment fee and interest, which will be calculated daily from the date of invoice, and charged at a rate of 13.2% per annum.
- 8) **Deposit**
A deposit of \$150.00 is required for all rentals. This deposit can either be paid by cash or credit card details can be supplied. The hirer acknowledges that H₂O Pro will deduct the cost of any damage or over due fees, including late return fees, from the deposit.
- 9) **Use of Goods**
The hirer shall not use the hire goods for any purpose other than for which they are supplied.
- 10) The hirer is not to hire, loan or otherwise allow any other party to use the goods without the express written permission of H₂O Pro Pty Ltd.
- 11) Licences and permits in respect of the goods supplied, are the responsibility of the hirer.
- 12) The Hirer also confirms that they know how to use the item(s) of equipment and that they hold any applicable qualifications which are required to use the hired equipment. The Hirer acknowledges that H₂O Pro will not be providing instruction in the use of the equipment nor will they supply the equipment with any instruction manuals.
- 13) **Ownership**
Hire goods remain the property of H₂O Pro Pty Ltd at all times.
- 14) **Condition of Goods**
H₂O Pro Pty Ltd will claim from the hirer the value of any equipment lost, damaged or stolen whilst in the care of the hirer. The hirer acknowledges that H₂O Pro will deduct the cost of any damage from the deposit and that they will also pay any additional amounts if the deposit does not cover the cost of the damage / loss.
- 15) H₂O Pro Pty Ltd warrants that the rental equipment is in satisfactory condition. Whilst all due care will be taken to ensure that all equipment is serviced in accordance with manufactures specifications, the hirer must advise H₂O Pro Pty Ltd immediately of any equipment malfunction.
- 16) **Late Returns.**
Late returns will be charged at the daily rate plus a fee of \$30.00 per 24hr period or part thereof. The hirer acknowledges that H₂O Pro will deduct the cost of any over due fees, including late return fees, from the deposit.
